

CAPACITY BUILDING FOR MIGRATION MANAGEMENT

About the Project

The project aimed to contribute to building migration capacity partnerships by establishing a permanent and accredited regional training institute offering quality-assured, bespoke learning and coaching that result in certification for migration actors. Improved governance and strategic partnerships were achieved through the establishment of a Permanent Further Education Institution that fostered collaboration between key stakeholders in the region. Additionally, the project reinforced the technical and professional capacities of migration actors through targeted training and development initiatives. A comprehensive network of premises, trainers, and programmes was established, ultimately bridging geographical gaps and reaching a diverse group of trainees. Moreover, the adoption of technological innovation and digital transformation modernised capacities, enhancing the effectiveness of migration actors and allowing them to tackle the complexities of migration more efficiently.

Activities



Establishment Phase

During its establishment phase, the MCP Med TI successfully laid and tested the essential physical, institutional, and regulatory foundations, culminating in its current status as a fully licensed and trusted training provider and regional partner. Achievements include becoming a formally accredited vocational training institute and awarding body authorised to develop and deliver courses globally, issuing European-recognised qualifications and ECTS credits—an unprecedented milestone in the migration sector; obtaining the ISO 21001:2018 certification; establishing a comprehensive, state-of-the-art Learning Management System; creating organisational and coordination structures such as the Governing Board and the Technical Advisory Group; licensing premises in Malta and identifying the first training needs and priorities with project beneficiaries.

Transition Phase

During this phase, the MCP Med TI procedures and processes were enhanced, and comprehensive training materials were developed and submitted for accreditation by the Maltese Authorities. The trainers and training premises network was established through active engagement of the EU and Southern Partner Countries (SPCs), allowing training delivery beyond Malta. In addition, a business model and funding strategy for the training institute was developed which considered potentially broadening the scope to include more beneficiary countries and agencies, ensuring long-term viability and regional impact.

Consolidation Phase

Following the transition phase, the project made significant strides in its objectives, resulting in improved governance and strategic partnerships achieved through the establishment and the full operationalisation of the MCP MED TI. It reinforced the technical and professional capacities of migration actors through targeted training and development initiatives. The project ensured accessibility by expanding its reach to 735 students with 520 earning European-accredited qualifications through of a comprehensive network of +10 premises, +100 trainers, and +24 accredited training programmes, ultimately bridging geographical gaps and reaching a diverse group of trainees. The adoption of technological innovation and digital transformation modernised capacities, enhancing the effectiveness of migration actors, and improved monitoring, evaluation and learning processes. The TI model was tested and complete ownership was achieved through SPCs autonomously delivering European accredited migration courses to SPC audiences, using SPC Authorised Trainers in formally licensed SPC premises, issuing European qualifications and academic credits thus promoting a transformative and sustainable approach to learning and professional development for migration actors. During this stage, a sustainable funding mechanism was also rolled-out thanks to SPCs in-kind contributions, traditional donor funding as well as synergies with other ICMPD initiatives.
