# P-ACT 4P-ACTIONS AGAINST TRAFFICKING IN HUMAN BEINGS

## About the Project

This MPF Technical Assistance project aims to combat human trafficking (THB) in Türkiye through enhanced early identification and referral processes, supporting victims with comprehensive assistance, and preventing trafficking through international cooperation. The main activities will focus on strengthening victim identification and prosecution, developing coordinated prevention strategies along trafficking routes, and strengthening Türkiye's operational capacity, in particular with support to the Presidency of Migration Management (PMM). These efforts aim to create a robust framework against human trafficking, ensuring effective response and prevention across Türkiye.

This project is implemented by the ICMPD office in Türkiye under the Technical Assistance and Services Component of MPF.

## Activities



### Capacity Building and Coordination for Strengthening Early Identification, Referrals and Prosecution Procedures

Under this component, annual coordination meetings, consultation meetings with judges and prosecutors and capacity building trainings for law enforcement officers are planned.



### Strengthening PMM's THB operations and procedures by providing support to its physical infrastructure

To support the PMM's physical infrastructure, activities include refurbishment of 2 THB shelter(s), procurement of equipment for Provincial Directorates of Migration Management (PDMMs) with high THB case load.



### Multi-faceted prevention through awareness-raising at national level and through coordinated approaches along trafficking and migration routes

Procurement and translation of key documents on trafficking in human beings, organisation of regular awareness-raising meetings for local stakeholders, production and dissemination of information materials on trafficking in human beings, organisation of a study visit to a country of origin as well as a study visit to major country of destination are planned to increase awareness at national level.
