Ukrainian Consultation Centre in Gdańsk (UCC Gdańsk)

About the Project

This project aims to support displaced Ukrainians through a Ukrainian Consultation Centre (UCC) in Gdańsk, Pomeranian Voivodeship, Poland. Located next to the Consulate of Ukraine, the Centre provides face-to-face, phone, and online consultations on temporary protection status, legal stay, accommodation, healthcare, employment, education, consular services, and legal matters. By responding to the information needs of displaced Ukrainians and strengthening cooperation with the Ukrainian Consulate, Polish authorities, and international organisations, the UCC in Gdańsk will reinforce institutional coordination and promote sustainable assistance to displaced Ukrainians in Poland and neighbouring countries.

Operationalisation of the UCC in Gdańsk

The Ukrainian Consultation Centre in Gdańsk will offer displaced Ukrainians in Poland legal, administrative, and consular information through in-person, phone, and online consultations. It will manage a data system, maintain regular client feedback mechanisms, and deliver up-to-date responses based on continuous analysis of frequently asked questions and emerging trends. In collaboration with the Ukrainian Consulate, Polish authorities, and international organisations, the Centre will also participate in joint outreach activities, cultural events, and information sessions to promote coordinated and sustainable support.



Networking and Information Sharing

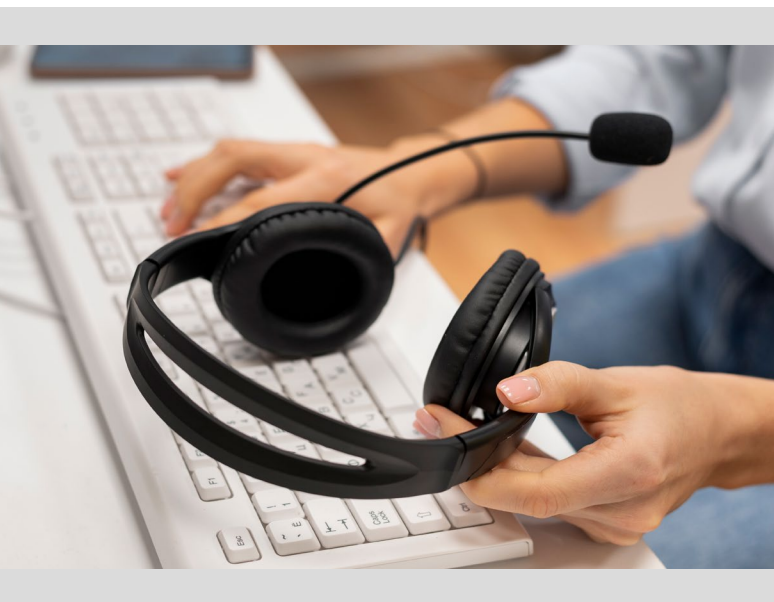
The project will strengthen cooperation between the UCC in Gdańsk, the Ukrainian Consulate, the Polish authorities and international and local organisations to ensure sustainable assistance for displaced Ukrainians. The UCC in Gdańsk will also engage in horizontal exchange and knowledge-sharing with the Call Centre in Warsaw and the network of UCCs in Czechia and Germany, contributing to cross-country referrals, shared lessons learned and consistent information provision across EU Member States.
