About the Project

This project aims to facilitate the orderly mobility of displaced Ukrainians in Poland while supporting human capital and cooperation frameworks essential for Ukraine's long-term recovery. By maintaining and expanding the operations of the Ukrainian Consultation Centre in Gdańsk and the Call Centre in Warsaw, both established by ICMPD under previous initiatives, the project supports displaced Ukrainians to make informed decisions regarding their future, whether navigating changes in their legal status or preparing for a safe and sustainable return and reintegration.

Activities



Operationalisation of the Call Centre in Warsaw and UCCC in Gdańsk

Under U-SUPPORT, the Call Centre in Warsaw and the Ukrainian Consultation Centre in Gdańsk will continue operating to provide accurate, evidence-based information and high-quality consultation services to displaced Ukrainians. Both centres will offer in-person, telephone and online consultations and referrals, information sessions and mobile consultation fairs, addressing legal and administrative issues, offering guidance on temporary protection matters and supporting vulnerable groups with complex legal cases. In parallel, the existing centre in Gdańsk will gradually be transformed into a Ukrainian Consultation and Community Centre (UCCC). This enhanced model will fully align its functions with the European Council Recommendation on information provision, specifically aimed at empowering displaced Ukrainians to make informed decisions regarding their legal status and future mobility.



Strengthening the Role of the Ukrainian Diaspora organisations in Poland to enhance Ukraine's resilience and recovery

The project will strengthen the capacities of Ukrainian diaspora organisations in Poland to sustain and deepen ties between displaced Ukrainians and their home country, thereby contributing to recovery efforts. A mapping study will be conducted to analyse best practices and effective models of diaspora engagement in post-crisis recovery. The findings of the study will underpin a practical toolkit and targeted training, establishing a structured framework for diaspora-led initiatives that support sustainable return and community-based reintegration.
